 - You can't manage what you don't measure




Focus Area #1 – Consumable Goods

- Met with distributor
- Reviewed criteria for chemicals
 - Shared standard with vendor
 - What met criteria
 - If not met what is available that does meet criteria
- All chemicals met standard
 - Exception was disinfectants
 - Vendor working with their supplier



Result

- Reduced chemicals purchased from 30 to 8
- Paper products meet criteria
- Can liners meet standards
- Soap & sanitizer meet standards
- Streamlined inventory system
- Simplified and improved training
- Created more flexibility



Focus Area #2 - Powered Equipment

Met with distributor - verified each piece to standard

- 2805D RIDE ON FLOOR SCRUBBER
- QUIETCLEAN VAC 12" W/ 10AMP MOTOR, WAND, & CREVICE TOOL
- XP EXTRACTOR, 16" PATH
- 20HD 20" FLOOR MACHINE
- SHOVELNOSE WET/DRY VAC, 18 GALLON, 9' VAC HOSE
- 27" LOW RIDGER BURNISHER W/ DUST CONTROL
- EDGE WALK BEHIND FLOOR SCRUBBER
- AM2500D AIR MOVER 250W***



Result

- Purchased more than 60 pieces of equipment that meet standard
- Original Air Movers didn't meet criteria
 - Asked supplier for acceptable options/alternatives
