

LETRS Grant



- Funding for Language Essentials for Teachers of Reading and Spelling (LETRS) training or another program endorsed by the Center for Effective Reading Instruction as an Accredited Independent Teacher Training Program
- LEAs & CESAs participated in 2022 and 2023
- Potential opportunity for LEAs and CESAs in 2023/2024

LETRS Grant

Costs

Vendor training costs for staff who successfully completed the LETRS training or another program endorsed by the Center for Effective Reading Instruction

Eligible Entities

LEAs and CESAs who opted in to participate in the LETRS Training Reimbursement Program


Amount

\$4,000 is available for each eligible entity. For entities that choose to participate, the funding is available for any eligible training costs that were incurred in FY21-22, as well as training costs through June 30, 2024

- \$2,000,000 total; \$4,000 per eligible agency
- First round participation response was due to DPI on July 8, 2022
 - watch for future opt-in message
- Vendor payment costs <u>only</u>

LETRS Grant Statistics

- 323 subrecipients
- \$2 million allocated (more to be added)
 - \$919k claimed (46%)
 - \$1.08 million balance (54%)

Out of School Time (OST) Grant



- Programs must address academic, social, emotional, and mental health needs of students most impacted by the COVID-19 pandemic
- LEAs and CBOs awarded funds through competitive grant process (Fall 2022)
- Examples: mentoring, tutoring, programs for individuals with disabilities, programs for English learners

Out of School Time (OST) Grant

- \$5,000,000 awarded to 17 Community Based Organizations (CBO) for Out of School Time programming
- \$15,418,674 awarded to 44 LEAs for Evidence-based After School programming
- Recipients will be receiving reporting forms to complete in September 2023 and August 2024



Summer School Grant



- Programs address the academic, social, emotional, and mental health needs of students most impacted by the COVID-19 pandemic through high quality and evidence-based summer learning programs
- LEAs awarded funds through competitive grant process (April 2023)
- Examples of allowable activities: programs that build STEM skills, remedial education, art & music programming

Summer School Grant


- \$15,418,674 awarded to 48 LEAs for Summer School programming
- Recipients will be receiving reporting forms to complete in September 2023 and August 2024



Educator Prep

Supplemental Funds

- \$600,000 Landscape analysis of educator preparatory programs
 - Vendor: TeacherPreparation Inspection-US(TPI-US)
- \$1,300,000 UW System educator preparatory grant programs



ESSER Compliance Information



Education Stabilization Funds (ESF) Monitoring

- LEAs selected through a risk assessment by DPI
- Factors are:
 - Student assessment & graduation data
 - Inequitable distribution of teachers
 - Combined allocations for all Federal grants
 - Monitoring history
 - History of past single audit findings
 - History of late application and late report submissions





Education Stabilization Funds (ESF) Monitoring

- Spring 2023, 14 LEAs went through comprehensive monitoring
- More information and resources can be located in the <u>ESF Monitoring Guide</u>
 - Updated version coming Fall 2023
- LEAs will be notified in the Fall of 2023 if they have been selected

Maintenance of Equity

FY 2021-22 & FY 2022-23

LEAs may not reduce per-pupil spending or staffing for high-poverty schools at a greater rate than the reductions (if any) that are applied to all schools in the LEA

Exceptions:

LEA faces one-time implementation challenges due to the enactment of the ARP Act in March 2021 and the impact of the pandemic

Davis-Bacon and Related Acts



Davis-Bacon and Related Acts

- All contracts involving labor that exceed \$2,000
- Locally prevailing wage and benefits
- Pay covered workers weekly
- Obtain weekly certified payroll records
- Prevailing wage determination posted on the job site
- Davis-Bacon labor standards clauses included in LEA contracts
- Davis-Bacon requirements included in written procurement procedures

Davis-Bacon and Related Acts

Overview of what auditors will look for:

- Procurements made with federal funds comply with the federal regulations for procurement including Davis-Bacon requirements and local written procurement procedures
 - Prevailing wage
- LEAs verified that their vendors were not suspended, debarred, or otherwise excluded



Surveillance Equipment and ESSER

- Consider alternative fund uses: <u>How American Rescue Plan Funds Can</u>
 <u>Prevent and Respond to Crime and Promote Public Safety</u>
- ESSER and GEER Use of Funds FAQ question B-14
- Costs must prevent, prepare for, and respond to COVID-19 including addressing students' academic, social, emotional, and mental health needs
- Surveillance activities must comply with federal civil rights laws to ensure nondiscrimination based on race, color, national origin, sex - including sexual orientation and gender identity, disability, and age
- Clearly established policy on the use of video systems on school property
- Student privacy concerns and FERPA
- Community and LEA stakeholders supported the use of federal ESSER funding on purchasing surveillance systems



ESSER and WISEgrants

Keep Grant Contacts up-to-date

Grants found in prior WISEgrants fiscal years, so be sure to update the ESSER grant contacts to ensure your staff are receiving important notifications

Multiple subbudgets: Funds 10, 27, 50, and 80

When revising multiple subbudgets that are fully allocated, you may need to submit one subbudget at a time if shifting across Funds

Indirect Cost Recovery

Uses unrestricted indirect cost rate (no "supplement, not supplant" provision)

Ensure indirect costs recovered are based on amount of modified total direct costs claimed in each fiscal year

Required Quarterly Claiming

Claims due within 90 days of end of quarter

- Period ending date June 30 is due September 30
- Period ending date September 30 is due December 31 (ESSER II final claims due December 8, 2023)
- Period ending date December 31 is due March 31
- Period ending date March 31 is due June 30
